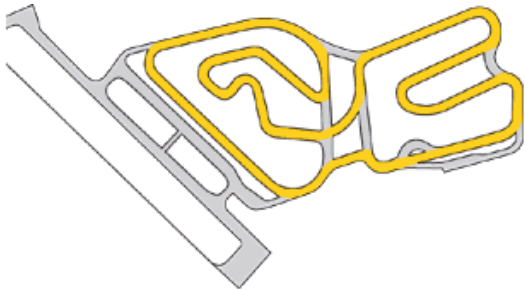




# BeaverRun Motorsports TRACK INFIELD PASS



Counter-Clockwise

In exchange for being granted access to the *Beaver Run Motorsports* track infield during an OYL event, you must abide by the following stipulations:

- Maintain a distance of 10 feet from the track surface.
- Maintain a distance of 20 feet beyond the racing line apex of each corner.
- Face the oncoming track traffic at all times.
- Avoid crossing the track surface whenever possible.
- Cross the track surface only when it is clear of traffic for at least 100 yards.
- Do not assist racers except in extreme emergency situations.
- Leave injuries to the care of qualified medical technicians. Never move downed riders.
- Do not distract or in any other way interfere with the racers, track officials or medics.

In consideration for granting me access onto the race track infield during an Ohio YSR League (hereafter referred to as the OYL'ers); and in consideration of the promotion and operation of road race events by the OYL'ers; and consideration of the granting of permission to enter, use, and remain on the track facilities and/or premises at which these events take place by the owners and/or representatives thereof, I hereby, for myself, my heirs, personal representatives and assigns, release, discharge and agree to hold blameless and indemnify the OYL'ers, it's owners and agents, employees, and/or members of all of them and from any liability loss, claims, demands and possible causes of action that might otherwise accrue from a loss, damage or injury (including death) to my person or property, in any way resulting from or arising in connection with or related to, any event, and whether arising, while upon, entering, or departing from said track facilities and/or premises, from any cause whatsoever, including, without limitation, the failure of anyone to enforce rules and regulations, failure to make inspections, or the negligence of other persons.

I understand that motorcycle racing competition can constitute a hazardous activity and that by being allowed access to the race track for an OYL'ers competition, and/or my participation in or presence at any competition event, I am assuming all hazards and risks related thereto.

The undersigned consents to be given medical services at the scene of the emergency, said scene shall include trackside site of the incident causing the emergency and any first-aid or emergency medical services facility located at the racing facility. The undersigned understands that such medical services will be rendered in accordance with and reliance on various statutes designed to encourage the giving of emergency medical services without liability for civil damages.

I have read this application in its entirety and stipulate, under penalty of perjury, that all statistical information set forth herein by me is true and complete.
